## ISOTHERMAL COMMUNITY COLLEGE BOARD OF TRUSTEES JULY 20, 1978

The Isothermal Community College Board of Trustees met on Thursday, July 20, 1978 at 5 p.m. in the Board Room.

Present were: James T. Tanner, Chairman, Ivy Cowan, Robert Spratt, Janie G. Callahan, Joe Miller, Ernest Yelton, Doug Pearson, William DeBrule, Jack Buchanan, And Clyde Tomblin. Chairman Tanner called the meeting to order.

Minutes of May 26, 1978 and June 30, 1978 were approved.

### Resolution

Chairman Tanner presented to the Board of Trustees a resolution of appreciation and respect for the long and excellent service of Fred J. Eason. The Board unanimously approved this resolution and directed that the resolution be written into the official minutes.

### Financial Matters

Dr. Morrow presented the original budget in the amount of \$36,200. which had been approved by the Board of Trustees on May 26, 1978, and a copy of the revised budget showing funds allocated by the County for FY 1978-79 in the amount of \$300,000. Dr. Morrow advised the Board that \$58,630.88 of FY 1977-78 allocation would be reverted to the County. Dr. Morrow recommended to the Board that \$30,000. of the \$58,630.88 being reverted to the County be requested for the maintenance and operation of the Physical Education/Student Services Building.

A motion was made and seconded that the Board accept the revised budget. The Board unanimously approved.

A motion was made and seconded that Dr. Morrow, along with members of the Board of Trustees, approach the County Commissioners and request \$36,000. of the 1977-78 reversion. The Board unanimously approved.

Dr. Morrow presented a letter which he had written to Dr. Ben E. Fountain, Jr., State President, requesting additional funds.

### Personnel Matters

Dr. Morrow stated that a night security guard would be hired in the near future.

Dr. Morrow recommended the following instructors be approved for FY 1978-79:

Bob Waters Peggy Blanton Steve Coyne Martha Layton Cosmetology Math English Reading

Beginning September 1, 1978

Three months contract

A motion was made, seconded and passed unanimously that the new instructors be approved.

Dr. Morrow requested that Kay Lieser be granted a six months maternity leave beginning September 1 through February 28, 1979. A motion was made and seconded that this request be granted. The Board unanimously approved.

Mr. Tanner requested that the Nominating Committee meet and recommend new officers for FY 1978-79 to the Board at the next meeting.

The meeting was adjourned.
