RESOLUTION
OF
BOARD OF TRUSTEES OF
ISOTHERMAL COMMUNITY COLLEGE

WHEREAS, the Board of Trustees deems it to be an important part of its curriculum for the educational enrichment of its students to obtain a broadcast license in the name of the College for the operation of a non-commercial educational FM radio station; and

WHEREAS, the Board of Trustees desires to obtain the financial assistance of the Federal government to enable it to obtain the necessary funds to meet the expenses of obtaining such a license and the administrative and start-up costs associated with beginning the operation of such a project;

NOW, THEREFORE, BE IT RESOLVED, that the Board of Trustees authorizes and approves the submission by the College and the execution and delivery by the appropriate officers of the College of an application to the Federal Communications Commission and to any and all other regulatory authorities as may be deemed necessary to obtain a broadcast license in the name of the College for the operation of a noncommercial educational FM radio station to be operated by the College; and

BE IT FURTHER RESOLVED, that the appropriate officers of the College are authorized and directed to designate sufficient funds of the College and to expend such funds in taking such actions and in making such applications as are deemed necessary and appropriate to obtain such a license and in applying for and obtaining the financial assistance of the Federal government for the administrative and operational expenses associated therewith; and

BE IT FURTHER RESOLVED, that the amount of funds to be designated by the College for the processing of any and all applications, a construction permit, engineering and legal fees and expenses, and station operation is an Administrative decision as delegated to the appropriate officers of the College by the Board of Trustees by these resolutions dated this 8th day of May, 1984.
