Academic Affairs

President Lewis announced that the Legislature has directed the State Board of Community Colleges to adopt tuition rate increases. Community college tuition for full-time students living in North Carolina will be \$11.50 per credit hour up to a cap of 14 credit hours and \$107.50 per credit hour with a cap of 14 hours for out-of-state students. Dr. Lewis reported that tuition rates for occupational extension courses will be increased to \$30.00 per course.

A motion was made by Howard Olson, seconded by Burtchus Lathan, to approve the political activity of Wilbur Wright, seeking re-election as Mayor of the Town of Ellenboro. The motion was unanimously approved.
