## **Appeal Approval Process**

If your appeal is approved, you will be notified by email. Your financial aid status will be updated to **Probation by Appeal**. This status will remain in effect as long as you continue to meet all the following standards each semester:

- Complete at least 75% of all attempted classes
- Maintain a minimum semester GPA of 2.25
- Register only for courses required for your active, primary program of study
- Remain in current academic program (Max Time Frame only) –
   If you change programs after your appeal is approved, the appeal becomes void and a new appeal will be required

If you are appealing due to exceeding the maximum time frame, an Academic Plan form will be sent by Financial Aid staff to your college navigator/faculty mentor for completion. This plan is used to outline your expected completion timeline, as Max Time Frame appeals are limited to a maximum of four semesters.

Failure to meet these standards will result in termination of your financial aid unless you qualify for a second appeal based on a **new, documented extenuating circumstance**.

You may submit a maximum of **two SAP appeals** for Pell and state grants. A third appeal may be submitted for **Powers Scholarship eligibility only** and must also be based on a new extenuating circumstance.

Continued appeal eligibility is reviewed after final grades are posted each semester. You will be notified of any change in status by ICC email.
